## **Charges-Payments**

- All above mentioned prices do not include VAT.
- Subscription for the package is activated upon prepayment of total fee.
- The adjustment of prices to services by the author company Orgadata AG affects the final cost of renewals and future subscriptions, as they are provided by Alumil SA to its customers. This price adjustment may occur every January 1<sup>st</sup> of the following year and will be announced in September of the current year on the website of Alumil SA. This amendment shall also be communicated to the customer along with the offer for renewal, approximately one (1) month before the end of the current period. Provided that the customer disagrees with the upcoming price adjustment, he/she shall inform Alumil SA. within the time period specified in the signed offer. In this case the subscription is not renewed, and the license key must be returned within one (1) calendar month upon expiry date of the signed offer.

### Important notices regarding renewal of the service

- Any change in customer's identity and contact address should be reported in writing to Alumil SA.
- Customer is obliged to inform Alumil S.A one (1) month prior to expiry date of the rental period if he/she intends to renew or not the subscription.
- In case the customer requests a renewal offer, Alumil S.A will issue new offer and customer should pay within a given period of the agreed amount.
- In case the customer doesn't want to continue with a renewal offer, he/she should inform Alumil S.`A with written statement about the service termination.
- After the expiry date, if none of the above actions have taken place or if the customer neither responds nor pays the free for the renewal, then the subscription will automatically be ended, and dongle key will be remotely locked. In this case subscription will not be renewed and the customer is obliged to return the dongle key within one (1) month upon expiry date of the signed offer.

#### **Contractual penalty**
